Hike to Plan/Plan to Hike Richmond Marina Bay Trail-Northern California

The hike was co-sponsored by the California Planning Round table (CPR) and APA Northern Section raised for California Planning Foundation student scholarships."

CPR member Hanson Hom provided the following recap about the event:

"A well-attended Hike to Plan/ Plan to Hike event was held on Saturday, April 19 covering a 5-mile segment of the Richmond Marina Bay Trail, which is part of the San Francisco Bay Trail. The hike was co-sponsored by the California Planning Roundtable (CPR) and APA Northern Section, and \$625 was raised for California Planning Foundation student scholarships. Additionally, the event was approved for 3.5 units of AICP CM credits. Registration through EventBrite was fully sold out with 35 people in attendance, including CPR members Alex Hinds, Elaine Costello and Mark Rhoades."



San Dieguito River Park Trail Hike: River and Trail Planning

Another successful *Hike to Plan, Plan to Hike* event was held on a warm, sunny day at the San Dieguito River Park Trail on Saturday, May 31, 2014. Co-sponsored by the APA California Chapter San Diego Section and the California Planning Roundtable (CPR), the hike sold out at 30 persons who collectively contributed \$850 towards California Planning Foundation Student Scholarships that are given annually to



planning students from colleges and universities throughout California. After an overview of the history and ecology of the River Park Trail and its planning by Shawna Anderson, AICP, Principal Planner with the San Dieguito River Park Joint Powers Authority (JPA) and Mark Carpenter, Senior Associate at KTU+A, we hiked about 4 miles of the 55 mile trail that runs from the ocean at Del Mar to Volcan Mountain, just north of Julian.

Bike to Plan/ Plan to Bike CV Link-Inland Empire

In collaboration with the APA Inland Empire Section, CPR organized a slightly different version of the traditional Hike to Plan/Plan to Bike event. Instead, organizers found the opportunity to ride bicycles along the proposed route of CV Link, a multi-purpose active transportation trail that would connect communities along a 50-mile span in the Coachella Valley from Palm Springs to the City of Coachella. Besides being a lot of fun, the event raised over \$200 for the California Planning Foundation scholarship fund.



WORK GROUPS

CPR continues to move forward with several initiatives to advance thinking and applications for key planning issues Californians face.

Infill Development

Overcoming Obstacles to Infill Development. Urban planners are increasingly called to address urban challenges with strategies that rely on infill development, which is increasingly recognized as leveraging regional and local benefits. CPR's "Infill Work Group" is examining principal challenges to infill development. In partnership with planning leaders and other organizations, CPR will publish a series of articles that recommend promising policies, practices and tools, beginning summer 2015.

Planning for Economic Development

Because of the importance of economic development and public financing, particularly in a PostRecession and a Post-Redevelopment world, to what we do as planning professionals to create better places and plans that can be implemented, the Economic Development Project is proposed to continue as an important part of the Roundtable's mission. Over the past several years we have focused on monitoring the changes in legislation at the State level that has addressed financing community and urban reinvestment in a Post-Redevelopment context. In addition to educating ourselves about these issues and coordinating with the Cal Chapter APA legislative activities, legislation has been drafted by Bill Anderson that would allow local communities to voluntarily vote on taxing themselves for financing community reinvestment. In the following year, we plan to follow up on this effort and also to begin to understand and evaluate new legislation that is being adopted for both economic development and urban revitalization, and to propose new economic development and financing concepts where appropriate.

Healthy Communities

Healthy Communities planning is the propeller advancing collaboration between planning and public health and the Social Determinants of Health (SDOH) is the concept that succinctly provides the scientific and practical understanding for the intersection of these two disciplines.

The California Planning Roundtable's (CPR) Healthy Communities Workgroup believes that planners have an important contribution to make by improving SDOH. To that effect, CPR will be creating tools designed to expand our planning



repertoire, including the development of greater channels for collaboration with public health professionals. To accomplish this goal, the work group has reached out to a selected group of planning and public health experts to develop these tools. A "Health Matters" survey was conducted to identify the best platforms to disseminate this the SDOH concept, the results will be published in the spring of 2015 along with a paper on the subject.
